

A Diner's Story: Edesse

Relationships were difficult for Edesse. She didn't stay with the fathers of her daughters and her first marriage was extremely short-lived. Her husband of two months left her to move to Florida. A second marriage at age 31 lasted for 21 years, but was not a healthy partnership as they fell into meth addiction together. They were addicted for 10 years and then they both decided to quit. When I asked if it was difficult she answered without hesitation, "No, I was done".

After that they settled in Bend. Edesse claims that eventually her husband kicked her out of their house. He didn't love her like she loved him. She moved in with her older daughter for five or six months. Eventually, her daughter drove her to the Bethlehem Inn and dropped her off. She said she sat outside and cried her eyes out and was so scared. However, she grew to love the Bethlehem Inn as it has allowed her to get on a healthier schedule, quit smoking and loose weight.

Now, Edesse stays with an elderly woman who needs her support to not fall and to take the correct medications. She pays Edesse \$150.00 a month towards food. This set up works fine for now but her dream is to have a place to call her own.

She has applied for HUD housing, which selects individuals for their homes through a random drawing selection. This can take years. She has also submitted her name at Crest Butte, an apartment complex by the hospital that allows individuals to pay on a sliding scale basis. It would be her preference to live at Crest Butte as she has friends there and feels they are nice.

Since Edesse had shared with me her diagnoses of epilepsy, social anxiety disorder and vertigo, I thought to ask her about her experience of coming to Family Kitchen for her first time. With social anxiety issues, coming into a new place can send her into a panic attack and keep her from functioning. She says she had to face her fears and is happy she did because Family Kitchen has been such a help to her in meeting monthly costs. She considers the diners to be "very nice" and the volunteers to be "fantastic!"

I was about to ask her about her dreams for her future when someone walked in the front door to the kitchen and she yelled out across the crowed room, "Debbie!" She tells me with great excitement, "She is the first person I met when I came to the Family Kitchen!"

Debbie rushes over, they embrace and start sharing how each other look so good, how are you, what have you been doing, have you seen..., how is...I was touched to be discreetly observing two dear old friends see each other after a long period, catch up a bit and offer each other such love and support. Debbie is working and doing well. She is proud of Edesse for quitting smoking and said it takes a strong person.

I fade into the background as it is apparent they have much to catch up on. I am always touched by the extraordinary humanity revealed through the quiet interactions of diners at Family Kitchen.

Oregon Community Foundation on Deferred Giving

The Oregon Community Foundation (OCF) is an option for you and/or your finance professional in preparing for charitable estate planning. Some information from their website:

Deferred Giving Options

Simple Bequests

Donors who leave a bequest to charity can take an estate tax deduction of 100 percent of the gift's value. Your bequest can be stated as a set amount of cash, securities, or other assets; or as the "residue" or a "percentage of the residue" of the estate. The bequest can also be contingent.

Charitable Remainder Trusts (CRT)

[Donors] may transfer assets to a charitable remainder trust that provides a specified distribution percentage to one or more (income) beneficiaries for life, or a term of years, with the remainder interest paid to charity. There are two kinds of CRTs:

Charitable Remainder Unitrust. A CRUT requires annual revaluation of the trust assets — which typically changes the value of the unitrust payment — and allows donors to make additional gifts to the trust.

Charitable Remainder Annuity Trust. The income beneficiary of a CRAT receives a fixed amount that is determined when the trust is established. A CRAT does not allow donors to make additional gifts to the trust.

Charitable Lead Trusts

A donor may transfer assets to a charitable lead trust. A charity is the income or "lead" beneficiary for a lifetime or term of years, after which the remaining assets are distributed to the donor or other beneficiaries.

Gift Annuities

In return for a donation of cash or other assets, the charity agrees to pay the donor — and/or someone designated by the donor — a fixed payment for life. The donor can claim an immediate charitable tax deduction for the amount of transfer above the value of the annuity purchase.

If a donor funds a gift annuity with long-term capital gain property — e.g., with appreciated stock — the donor will report only some of the gain, and may be able to report it in installments over many years. Donors may establish a deferred charitable gift annuity and defer receiving income from the gift annuity for a period of years.

OCF will consider issuing gift annuity contracts for annuities originating in Oregon that meet these guidelines:

- Minimum age of the annuitant is 60 (55 for deferred gift annuities.
- Annuity rate does not exceed the rate published by the American Council on Gift Annuities.
- Minimum gift amount is \$25,000.

Life Insurance/IRA Beneficiaries

IRA accounts listing The Oregon Community Foundation as the beneficiary are free of estate and income taxes. Not only can OCF be named as the beneficiary of a life insurance policy, but a donor can also transfer the policy irrevocably to the Foundation and claim an income tax deduction for the policy's cost basis or cash surrender value (whichever is less). Any subsequent premium payments will be deductible.
